Invalid for all purposes seven years after the date hereof

State of Ohio, Cuyahoga County, ss: In the Common Pleas Court of Cuyahoga County.

I, Domenico Richardi, aged 29 years, occupation laborer, do declare on oath that my personal description is: Color white, complexion dark, height 5 feet 8 inches, weight 165 pounds, color of hair brown, color of eyes brown, other visible distinctive marks none. I was born in S Gulliano del Sanimo Italy on the 29 day of August, anno Domini 1891; I now reside at 1951 East 123rd St., Cleveland, Ohio.

I emigrated to the United States of America from Naples Italy on the vessel Providence; my last foreign residence was Italy; I am married; the name of my wife is Cristina; she was born at Italy and now resides at Italy. It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to VICTOR EMANUEL III. KING OF ITALY, of whom I am now a subject;

I arrived at the port of New York, New York, in the State of New York, on or about the 13 day of September, anno Domini 1920; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
